Chief Bethencourt-PD- I like to thank you for taking the moment of silence in recognition of Det. Greco contribution to the Middletown Police Dept. He did a lot of things for our Juvenile Division. He served very well in that capacity. So thank you for that.

I also like to give big congratulations to Lt. Graziano. He was the 8th Middletown Police Dept. Administration to graduate from the FBI National Academy last Friday, the 11th.

Also want to thank you for allowing me to send the Administrative staff to that training which is widely recognized throughout the world as one of the best trainings for police profession.

Shared some crime numbers- Part 1 Crime which is the violent crime indicators as of November 30th of this year, is down 17%. That in includes burglary, arson, rapes, kidnapping.

It is an attribute to these men and women out there every day on the streets trying to make a difference in the City. I won't take credit for that.

Dept. of Criminal Justice Services has us at 19.4% down, 5 yr. average as of 10/2015 vs 2014.

More importantly and more significant is our 5 yr. average in the same crime index is down 35.7%, so over the last 5 yrs. we have shown a very significant decrease in violent crimes within the City.

Code enforcement arrests are up 3%. That focus is mainly on prohibitive acts involving City Parks, possession of alcohol and noise which is a big concern for city residents. Loud music from vehicles, etc.

Parking tickets are up significantly. I want to remind the residents of the City of the overnight parking ordinance. We are not out there trying to give parking tickets, but we do where it is appropriate. Reminder to the City residents, be familiar with the overnight parking violations.

Traffic situation in the City. We've continued to receive support and thank you to NYS Police Troop F division for continuing to send troopers to the City.

Total traffic tickets issued throughout the City of Middletown by the Middletown PD as of today was 3,722 traffic summons.

Total amount of tickets issued by the City of Middletown for speeding on Highland Ave. is 321 tickets. Just the speeding tickets.

Assortment of other tickets that were issued for equipment violation, cell phone violations, seat belts and the likes, 3 DWI to date that were on Highland since we started the initiative.

The statistics from the NYS Police they have as of the 11th issued 127 tickets city wide, 32 of them on Highland Ave. assortment of others were for seat belts, cell phones, distracted driver. We are continuing our efforts there and the State Police have pledged their continuing support into January of 2016. I don't know when they would ever pull them out as long as we request them.

I will continue to update you on the progress showing there. I do travel the roadways frequently enough to see there is significant impact that we are making.

I want to wish you a very Happy Holiday and Merry Christmas. To the residents of the City I would like to stress that if you see anything suspicious in your neighborhood follow the see something, say something motto and contact the Police Dept. 343-3151 or dial 911. Reminder that you can report suspicious activity anonymously. You don't have to give your name and we will take those calls and handle them same way as if you gave a name.

Happy Holidays and to the Middletown Community

Fire Chief Luis-FD-this year the FD is going to participate in Adopt a Family Program. We have adopted 4 families. We will be going out Christmas Eve to a couple of them and Christmas Day to a couple.

Ald. Kleiner- Awful lot of calls for smell of gas and calling O&R to the scene. Is this more than usual? Do you know what most of them end up being?

Chief Luis- A lot of them are faulty detectors. Some are accidental; like leaving your stove on with the flame not on. Some are CO; I don't think they are any higher as far as inside the homes go. Outside the homes I would probably say yes. Up in your neighborhood especially. We have been up there numerous times.

Ald. Kleiner-No specific problems.

Chief Luis-No.

Commissioner Tawil-DPW- Last meeting of the year. I want to wish everybody here a Happy New Year and Happy Holidays.

Genung Culvert work was done and completed by our men in the Water/Sewer Dept. They were working under difficult conditions. Had a 12 inch gas main on top of 12 inch water main. Thank God everything was completed without any accidents. They replaced 3x3 ft. wide culvert that totally collapsed. We replaced them with concrete that was emergency work. Finished within 2 days and worked OT. Did a great job.

Couple of water main breaks on Pine St. and Cottage St.

Last month we generated another \$40,000 revenue at the Waste Water Treatment Plant. Total revenue so far \$401,000. This was the promise we promised 10 yrs. ago in our WWP. We were under violation, consent order. Hopefully December will be another high number.

IPP – tentatively approved the EPA. Now they have to do the posting in their own circulars. After that we will start the hard work of implementing IPP (Industrial Pre-Treatment Plant).

This evening we had a phone call from the Police Dept. that one of the houses, abandon home on Wickham Ave. the whole basement was full of water and we needed help to shut the water off. It so happened the Common Council and the City they are starting a new program to replace all the water meters in everybody's house/business up to 1 inch in diameter. The new meters will have an alarm system if there is any, they will sensing the temperature, sensing any leaks, break in the house. If there is such a thing we will know about it and we will be notified. A signal will be coming to us and we will address the situation before it becomes an emergency with flooding condition.

The Mayor is away as you know and I am sure somebody will be talking. He sent me a text today and I spoke to him several times. He had a text from the Governor's Office that we have another \$150,000 for grant for one of our Waste Water projects that we will be undertaking next year. The rest of the funds, money, rest of the cost of the project it will be at almost zero or 1% interest. We will be getting more details.

Of course when he comes back, he will be updating on the grants that he was able to obtain for us for different projects.

Again, it is dark out there, Christmas please report to us any street lights that are out. You can report it directly to O&R. Just a reminder we have Code Enforcement Officers going out, they went out last night and going out tonight to look for Quality of Life issues at night. We cannot see everything, please report it to us.

Ald. Kleiner- That culvert you replaced, is that going to help the water go down as you go on Genung St. out of town, past David Moore Heights. That has turned into a lake, is that part of that problem?

Commissioner Tawil-No that has nothing to do with it; that was an old infrastructure that collapsed the one on Genung St. That is another matter. We are working with the Town of Wallkill and Town of Wawayanda to resolve that issue. We are doing everything we can from our end, the two (2) other towns are trying to get permission to get onto private property to move the culvert. Downstream from us and that aggravates the situation for us, we are trying to pump. We have been pumping there may be close to two (2) weeks now. Nonstop. Outside the City of Middletown. It is under the property that belongs to the City which is the railroad.

Ald. Kleiner-I did have residents who had asked.

John Naumchik/City Clerk-Tonight's agenda you will be voting on condensing the January 5th meeting into the January 4th meeting. That January 4th meeting is going to be the Re-Organizational meeting. That is required by the City Charter. No need to

Appreciate the folks who came out last night for the 2nd & 4th Ward combined meeting. We are starting to build up a little thing going. Good conversation, a lot of talk and a lot of exchanging of ideas. That is a good thing. I am looking forward of having that continue.

I just want to talk a little bit about the blackout on the 5th. One of the things that I try to talk about that is important to me is us maximizing our communication potential and utilizing our tools.

I found out later it was the Mayor who updated the Facebook Page for the City of Middletown. That gave an update, exactly what the situation was, estimated time when things hope to be restored. It was creditable information. It wasn't people out there speculating and doing everything. People tended to this page and to use Facebook

lingo it was 500 shares in about an hour. If you do some crazy math, it could easily be 100,000 people who had the opportunity if not more to get this information and get to somebody. I appreciate the effort done there. I really felt even in talking to people later on that they came here looking for information, they got it and it was a blackout. You waited it out and everything was fine. By all accounts I'm not minimizing any situations that may have happened but I heard it was relatively calm here. I just wanted to mention, thank the Mayor for taking the time to do that.

Ald. Johnson- I did not realize that Mr. Greco had passed. I had served with him on the Board of Education. I shared the Chief's observations he always had the best interest of the City at heart.

With respect to the Chief's report, you indicated the improvements were not necessarily to his credit, but remind him that we always hold the Commissioner, Chief, Dept. Head accountable when things don't go well; so I think you should be congratulated when things go well. Thank you very much for your leadership and effort.

With respect to Genung St. as you well know I travel that road 8 times a day. I did speak with Commissioner Ingrassia; I did notice the water was right up against the pavement edge. Apparently beavers are to blame and you can see some beaver dams if you look to your right as you are going into the Town of Wallkill. I think good intermunicipal effort that all 3 of us are working on that.

Also did happen to drive through the Genung St. area last Wednesday about 10:17 and it was daylight at that culvert; there were 8 guys in the hole, within 48 hrs. everything was done. Repaved, good to go. I congratulate their efforts on that.

Merry Christmas to all and to all a Good Night.

Ald. Ramkissoon-I want to take a moment to thank our Fire Dept., both paid and volunteer and the Police Dept. for their hard work during the blackout. 399.15 Resolution to amend the City Code to allow more than one driveway and/or wider driveways to service single family dwellings

On motion of Ald. Sommers seconded by Ald. Jean-Francois

Whereas, the Code of the City of Middletown currently allows only one driveway to be constructed on lots improved by a one family dwelling, and such driveway may only be no more than twenty feet wide and wide enough only to encompass one vehicle, and Whereas, the limitation on driveways for single family dwellings can impose a hardship on the owners and occupants of single family dwellings, and

Whereas, the Common Council is willing to change the law to allow more than one driveway and/or wider driveways to service single family dwellings.

Now, therefore, be it resolved and ordained by the Common Council of the City of Middletown that the existing Section 475-33 (A) (1) of the Code of the City of Middletown is hereby repealed and replaced in its entirety with the following:

Section 475-33. Off-street parking.

A. ... (1) Dwelling: At least one parking space for each dwelling unit in the building or buildings. No parking of any vehicles shall be allowed anywhere within the front yard of the lot upon which the dwelling unit(s) is/are located, except on a driveway which is no wider than 30 feet wide (unless the Commissioner of Public Works, in his sole discretion, allows a wider driveway to be constructed), and not more than two such driveways shall be allowed on such lot in the case of one-family and two-family dwellings.

Be it further resolved, that the first sentence of the existing Section 475-33 (C) of the Code of the City of Middletown is hereby repealed and replaced in its entirety with the following:

C. In all residential districts, no parking shall be allowed anywhere within the front yard of the lot upon which the dwelling unit(s) is/are located, except on a driveway which is wide enough to encompass up to three vehicles (unless the Commissioner of Public Works, in his sole discretion, allows a wider driveway to be constructed), and not more than two such driveways shall be allowed on such lot in the case of one-family and two-family dwellings.

Be it further resolved, that this resolution and ordinance shall take effect immediately.
