

**AMENDMENT TO THE
2014 ACTION PLAN COMPONENT OF THE
2010-2014 CONSOLIDATED PLAN FOR
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)
FUNDING AS PREPARED BY THE
CITY OF MIDDLETOWN
OFFICE OF ECONOMIC AND COMMUNITY DEVELOPMENT**

A. BACKGROUND

The City of Middletown Office of Economic and Community Development (OECD) submitted a final Action Plan Component to the 2010-2014 Five-Year Consolidated Plan to the U.S. Department of Housing and Urban Development (HUD) on November 7, 2013. A public review period was undertaken from October 2, 2013 through October 31, 2013. An amendment followed with a public review period undertaken from June 21, 2014 and ending on July 21, 2014. due to an unplanned 108 repayment. The following proposed allocations of Community Development Block Grant (CDBG) funding were made under the 2014 Action Plan:

The Amendment guidelines contained in the City's Final Consolidated Plan for 2010-2014 require that an Amendment be undertaken whenever the purpose, scope, location, or beneficiaries of a CDBG eligible

activity is changed in a material way, such that the same is no longer consistent with the initial proposed activity contained within the applicable Action Plan when adopted subsequent to modification made thereafter.

The City of Middletown in response to a reallocation of CDBG grant funds and in an effort to respond to possible changed circumstances within the community has identified that there is a need to create an Amendment to the 2014 Action Plan.

B. AMENDMENT

The Amendment to the 2014 Action Plan involves a reallocation of CDBG funding from the federal department of Housing and Urban Development, in the amount of \$31,807.

C. PUBLIC PARTICIPATION

A public comment period on the Amendment was conducted beginning on Saturday, August 30, 2014 and will end on Friday, September 5, 2014 in accordance with the HUD waiver dated August 13, 2014 to allow a seven day comment period.
